Vincent Bonnet will discuss this multi faceted problem, inspiring his audience in this 15 to 20 minute session to engage in active participation. The session will be moderated by Aldo Pirola.</p>	<p>Speaker Luca Bergamo, Secretary General of Culture Action Europe</p> <p>Moderator: Hella Klauser, EBLIDA EGCIS</p> <p>Summary: Luca Bergamo will elaborate on the European Agenda with a special focus on Creative Europe (the new programme for Culture 2014-2020), how to benefit from this programme and how to act in concrete terms. Luca will also show the role of Culture Action Europe on a political level and the importance of federating associations, libraries, people over projects in order to gain visibility from the European Institutions. The collected data reveals the existence of one generic strategic role and three more specific strategic roles (i.e. urban landmark, area-oriented herald and/or target group patron). Each strategic profile has specific implications for choices made concerning content- and process-related policy issues within the public libraries. The presentation identifies, depicts and illustrates the nature of these policy issues and as such alternative partnerships. Her speech will inspire the audience to engage in an active session moderated by Jan Braeckman (NAPLE) with the idea to apply Nathalie Vallet's findings to e-services in public libraries.</p>

EBLIDA who's who?

As the network evolves, and as new members enter EBLIDA's community, the EBLIDA newsletter has decided to open its columns to members wishing to introduce themselves to others. This month we feature :

**IAML: the International Association of Music Libraries,
Archives and Documentation Centres**



Founded in 1951 in Paris, IAML is a respected member of the international library and music communities. The Association currently has over 1800 members in 53 countries and membership is open to anyone with an interest in, or an involvement with, the provision of music in all sectors of the library and archives world.

IAML consists of a blend of personal and institutional memberships. In countries where there are sufficient numbers, a National Branch can be formed, and at present, there are twenty five of these around the world.

IAML maintains membership of several other organisations with which it feels a professional affinity, for example IFLA, the International Council on Archives and the International Music Council.

The main aims of IAML are:

- To encourage and promote the activities of music libraries, archives and documentation centres and to strengthen co-operation among individuals and institutions working in these fields
- To promote a better understanding of the cultural importance of music institutions nationally and internationally
- To promote professional education and training
- To support projects which improve the provision of music services through bibliography, cataloguing, preservation, research
- To promote the special needs of music within the general library framework

Activities take place on several levels. The international body has a number of committees and professional branches which cover all sectors and disciplines. Members meet at the annual conference, which in recent years has been held in Moscow (2010), Dublin (2011) and Montreal (2012). Future conferences are planned for Vienna (2013), Antwerp (2014) and New York (2015).

Conferences are sometimes organised jointly with associations that historically have a close connection with IAML, such as the International Musicological Society, the International Association of Music Information Centres and the International Association of Recorded Sound Archives. The branches and committees of IAML arrange sessions and working meetings over the six days of conference, and the host organising committees make sure that the music of their own countries is featured in concerts and plenary sessions.

IAML has three official languages: English, French and German. Sessions and articles in publications can be in any of these languages.

There have been many major achievements over the years; some of these have been in co-operation with other musical organisations, such as the following in partnership with the International Musicological Society:

RISM: Répertoire international des sources musicales

Documents the location of printed and manuscript music, and books about music, before 1800

RILM: Répertoire international de littérature musicale

A computerised abstracting service and bibliography of writings on music

RidIM: Répertoire international d'iconographie musicale

Documents visual materials relating to music

RIPM: Répertoire international de la presse musicale

Indexes music-related articles and illustrations from 18th to 20th century periodical literature

The administration of IAML depends, as in many similar organisations, on a huge amount of voluntary work by its members. The Board consists of a President and four Vice-presidents (each elected for a three-year term), and a Secretary-General and Treasurer (appointed for a four-year term). The immediate Past-president remains on the Board for a further three years to provide continuity.

The official journal of IAML, *Fontes Artis Musicae*, is a well-respected publication that not only provides the historical record of the Association, but also offers a wide range of articles and reviews of immediate interest to the profession. It is published four times per year. There is a regularly updated website (www.iaml.info) and an e-mail discussion list (iaml-l) which can also be used for tracing hard-to-find music and enabling loans or provision of copies.

Outreach is a long-standing and important part of IAML activities, as music libraries in many countries have little, if any, resources for stock purchasing and staff development. Assistance may take several forms:

Donating library materials to institutions in particular need or to libraries which have been affected by disasters.

Providing financial support to enable music librarians from economically disadvantaged countries to [attend](#) international IAML conferences.

[Giving advice](#) on professional matters, for example cataloguing, classification, and the establishment of new services.

Free memberships for a period of five years for a number of eligible institutions.

Following a long period of internal discussion, IAML, like many other institutions, is currently going through a process of restructuring. Having originally been formed to help bring order out of chaos for music resources in a world still reeling from the effects of war, the role of the Association has evolved as outlined above. It is essential now that the IAML finds itself in a strong position to face new challenges, not least of which are the ongoing effects of the global financial crises which is being used as an excuse for the dismantling and destruction of some important collections of the world's musical heritage.
