News round-up: EBLIDA and E.U.

FEP EWC event on remote access to e-books, Helsinki, 10 May 2013

EBLIDA took part in the event organised by the Federation of European Publishers (FEP) and the European Writers Council (EWC) to discuss remote access to e-books.

Best practices were a good start for the discussions. It was interesting to see that EBLIDA with the voice of its President was "the bad guy" in this session by stating that legislation is necessary to enable libraries to fulfil their tasks. Best practices are far from offering best solutions. The next event will be organised by in Autumn in Paris (France).

Licenses for Europe

Different situations, different actions in the dialogue.

- ◆ Cross-border access and the portability of services: EBLIDA involved in the discussions.
- ◆ User-generated content and licensing for small-scale users of protected material: no representatives from EBLIDA.
- ◆ Audiovisual sector and cultural heritage institutions: EBLIDA is involved in the discussions.
- ◆ Text and data mining for scientific research purposes: EBLIDA withdraws from the process.

The latest development in the Licences for Europe stakeholders dialogue have seen EBLIDA withdraw from working group 4 on Text and Data Mining because " [...] *While we are deeply committed to working with the Commission on the removal of legal and other environmental barriers to TDM, we believe that any meaningful engagement on the legal framework within which data-driven innovation exists must address the issue of limitations and exceptions. The current approach of the Commission instead places licensing as the central pillar of the discussion [...]* ". In working group 1 on cross-border access and the portability of services, the discussions included e-lending, interlibrary access to digital content without any result. At the last dialogue, EBLIDA pointed out that:

- ◆ publishers and libraries are not equal partners in this dialogue;
- ◆ licences make it impossible for libraries to choose which content they want to make available to their users;
- ◆ there are too many types of licences with too many terms and conditions;
- ◆ it is not true that from 1 library you can access the whole existing offer.

The plenary session planned for the 4th of July is unlikely to prove to be useful since the three Commissioners won't be there and all the MEPs will be in plenary session at the European Parliament in Strasbourg (France). The audience will mainly be composed of the organisations (mainly commercial entities) that haven't left the process yet.

However, EBLIDA should be there to hear the different reports and maybe give its perspective on the questions.

EBLIDA at the Torino Book Fair, 16th of May 2013



EBLIDA Director accompanied Stefano Parise, President of the Association of Italian Libraries, at the Torino Book Fair on the 16th of May.

Stefano Parise participated in a discussion on e-books in Libraries and the situation for libraries in Italy.

Speakers were professionals from the book chain (publishers, booksellers, web companies, librarians) and presented an Italian project resulting from the cooperation between publishers, booksellers and libraries. The project is called Media Library OnLine (MLOL).

Each speaker discussed the fact that pilot projects and experiments should be developed.

Stefano Parise took the opportunity of the discussion to introduce the EBLIDA campaign "the right to e-read" that was presented the day before at the EBLIDA conference by Gerald Leitner (see page 3). The current situation at European level is fragmented, however libraries have few rights in the e-books market. This proves that as well as national discussions between librarians and publishers, a European Campaign is necessary to raise awareness at European level.

Ready? Read 'e'.
E-services in Libraries,
from European thinking
to local Actions



The day after the Council, the EBLIDA and NAPLE Annual Conference was held.

The Conference welcomed about 105 (of the 127) registrants.

After the official welcome by the local representatives of the City of Milan, the AIB and NAPLE, EBLIDA President spoke about the importance of EBLIDA as a lobbying organisation in Europe and the undertaken actions. He was then seconded by Gerald Leitner, chair of the e-books Task Force who presented ideas worked out by the Task Force for the new EBLIDA campaign "*the right to e-read*". Participants welcome the information. Commissioner Vassiliou gave her speech by video message on her vision of the role of libraries in a developing digital environment (check it out at www.eblida.org). Luigi Berlinguer (Italian MEP) explained that copyright needs to be adapted to the digital environment and should not be an obstacle to the development of access to e-content in libraries.

The keynote speaker of the day, Gino Roncaglia gave a tremendous overview about the new reading environment that is developing in addition to traditional means like books under new formats such as SMS, blogs, twitter. The web is a landscape offering a horizontal perspective as well as vertical complexity. We are facing fragmentation of information.

It is therefore important to think of the different varieties of complex text in parallel with information literacy. A new task of libraries is to create a reading ecosystem in which all forms of complexity have to be addressed.

Libraries, as network of contents and services, should consider, in addition to preservation and access, information literacy, readers empowerment, services for social reading, content production. It is necessary to create a system of reading rights and competencies to understand legal agreement and reading agreement.

The speeches paved the way for an interesting panel discussion on strategies for libraries, as well as on the threats challenging democracy. The President of EBLIDA concluded the panel by stating that "economic interests should not threaten the public (general) interest".

The audience split into three groups for breakout sessions of 75 minutes. The report afterwards showed that libraries have an important role to play from local to European level, and that cooperation with social partners and politicians is important in order to ensure long-term development.

Gino Roncaglia wrapped-up by addressing 4 points:

- ◆ services and e-services;
- ◆ rights of the readers such as right of education, of access to information, right to use, reuse, etc.;
- ◆ legal questions: all questions related to rights/copyright/lobbying/policies/digital right management;
- ◆ content.

Klaus-Peter Böttger concluded the Conference by thanking all the speakers and participants and inviting them to join next year in Athens to continue the discussions and see the progress made by libraries in the European context.

The eBooks corner

EBLIDA publishes a new Position Paper "The right to e-read"

Since we have produced our "Information Paper on E-Lending" and our "Position Paper: European libraries and the challenges of e-publishing" last year in Copenhagen, a lot has happened in this field.

The distinction between physical and e-books is now under attack, both in the courts and the marketplace: On July 3rd 2012, the European Court of Justice very surprisingly decided in the case Oracle vs. UsedSoftware that resale of software is legal, even if it was purchased in the context of a permanent license and downloaded from the internet. Consequentially, the principle of exhaustion applies to the purchase of software through electronic download just as with physical media. Some legal experts argue that the same applies to e-books and the resale of legally downloaded e-books. More and more positions are published in the recent legal literature that say that the principle of exhaustion applies to the sale of e-books. That would be a sensation!

But the current situation is characterised by uncertainty. Consumers still have to sign ten-page terms and conditions of licenses before they can buy an e-book, consumer organisations sue e-books publishers and some e-books publishers refuse to sell e-books to libraries.

For libraries and their users, the situation is highly unsatisfactory: Many libraries have tried in recent years to build e-books services for their users, some with considerable success. But all these efforts could be in vain from one day to the next because in their interpretation of the copyright, publishers claim that e-lending is a service to which the principle of exhaustion does not apply. They state that rights holders are free to decide whether they want to give access to a specific work, and to decide on the terms and conditions for such access. Should this interpretation prevail, this would mean that primarily publishers decide on digital collections in libraries and not the librarians themselves in pursuit of their public tasks.

This is unacceptable in our view. We need a modern copyright framework, which eliminates this uncertainty, guarantees effective recognition and remuneration of rights holders and opens up greater access and a wider choice of legal offers via libraries to end users.

EBILDA has therefore prepared a new position that describes the current situation – which is significantly different than a year ago - and **calls on the EU Commission for a precise copyright framework that allows libraries to acquire and lend e-books and pay an adequate remuneration to the authors, just as with printed books to continue to perform their services for the benefit of all European citizens.**

Please translate this into your language. Inform your colleagues and politicians about the new situation.

But that's not all! EBLIDA has decided to launch a Europe-wide joint action of all library associations for "the right to e-read" together with you. We will keep you informed in the next issue of our newsletter.

EBLIDA who's who?

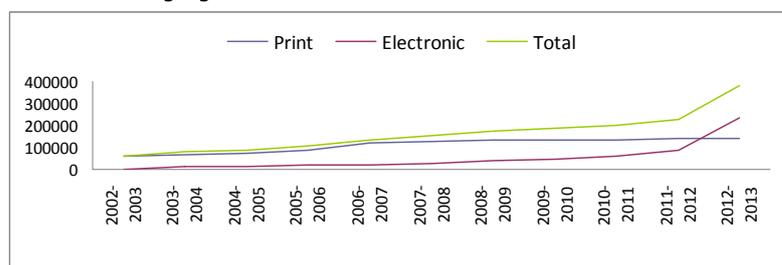
As the network evolves, and as new members enter EBLIDA's community, the EBLIDA newsletter has decided to open its columns to members wishing to introduce themselves to others. This month, EBLIDA opens its columns to: **Istanbul BILGI University Library, Turkey**

Bilgi Library exists since the university was established in 1996 as a private and non-profit institution. It has been part of Laureate International Universities since 2007. The university currently has around 13,500 students with 6 faculties ([Architecture](#), [Arts and Sciences](#), [Communication](#), [Economics and Administrative Sciences](#), [Engineering](#), [Law](#)) and 5 Vocational Schools ([Applied Sciences](#), [Health Sciences](#), [Tourism and Hotel Management](#), [Advanced Vocational Studies](#), [Justice](#)) and 52 undergraduate, 42 graduate and 15 associate degree programs.

Bilgi Library is located across 3 campuses as Santral, Kuştepe and Dolapdere libraries and also with 'European Union Information' and 'Cultural Policy and Management Research' Library. The library collection consists of a comprehensive range of the books, periodicals, e-books, e-journals, academic Internet resources, music scores audio-visual, sound recordings, etc. Bilgi Library is expand it's electronic resources collection in the near future. Please see the following chart showing the growth of printed and electronic collection:

Bilgi Library Collection by Numbers:

- ◆ Total number of printed resources are **141.858** and **66%** of them are in English language, **30%** are in Turkish and **% 4** are in other languages



- ◆ **82%** of the collection consists of books and the rest is DVD, VHS, Music CD, Music score.
- ◆ Bilgi e-library currently has **233.078** e-books, **35.300** e-journal and more than **103** e-databases. All these resources are accesible on and off campus for Bilgi Library members.
- ◆ **84.410** resources were borrowed in 2012.
- ◆ **10** e-reader devices have been loaned to library users since begining of 2012.
- ◆ Bilgi Library currently has **14** librarians and **30** part-time students are working.

In the library Millennium Automation Sytem which is the product of "Innovative Interfaces Inc." has been used since the year 2000.

Information Literacy is one of the main concerns of Istanbul Bilgi University Library. Because of the changing format of information we are forced to think about the future of the libraries. Everyone has right to access the realible information and in order to be accessible, information needs to be organized more than ever; and this organization process is already the ultimate role of a librarian. Hence Bilgi University library has been working on this issue in many ways. For example the library director **Sami Çukadar** has been giving a series of courses in faculty of law for 5 years. In addition to Information Literacy issue Bilgi Library is also concerned about the visibilities and future roles of libraries in the society. For this reason **Vildan Coşkun** and **Abdullah Turan** will attend a poster session at the **IFLA 2013** Conference in Singapore. The poster tells the photography exhibition of reading people all over Istanbul to attract attention to reading. The goal is to show the ways in which libraries can act regardless of time and space and in this way libraries can reach many people by using different mediums of communication such as organising exhibitions. The physical shape of a future library may be unknown yet; however we all agree that seeking information and reading will be exist for sure, therefore at least the concept of the library will never disappear. Bilgi Library collection is to support university degree programs, research and teaching as well as the intellectual needs of the students, teachers and all kind of researchers and in this context, Bilgi Library is open to everybody.
